

SUMMARY ANNUAL REPORT

FOR CHICAGO LABORERS' DISTRICT COUNCIL RETIREE HEALTH AND WELFARE FUND

This is a summary of the annual report of the Chicago Laborers' District Council Retiree Health and Welfare Fund, EIN 46-5243652, Plan No. 501, for period June 01, 2017 through May 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Chicago Laborers' District Council Retiree Health and Welfare Fund has committed itself to pay eligible claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$362,345,975 as of May 31, 2018, compared to \$299,245,930 as of June 01, 2017. During the plan year the plan experienced an increase in its net assets of \$63,100,045. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$122,052,485, including employer contributions of \$91,787,088, employee contributions of \$6,212,352, earnings from investments of \$22,220,737, and other income of \$1,832,308.

Plan expenses were \$58,952,440. These expenses included \$4,569,860 in administrative expenses, and \$54,382,580 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
