This is a summary of the annual report for Chicago & Vicinity Laborers' District Council Retiree Health & Welfare Plan, EIN 46-5243652 Plan 501, for the year ended May 31, 2022. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$623,935,788 as of May 31, 2022, compared to \$641,146,326 as of June 1, 2021. During the plan year, the plan experienced a decrease in its net assets of \$17,210,538. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$74,601,070 including employer contributions of \$97,942,777 participant contributions of \$7,438,504, realized gains of \$440,951 from the sale of assets, net investment losses of \$(46,977,725), and other income of \$15,756,563.

Plan expenses were \$91,811,608. These expenses included \$5,972,506 in administrative expenses and \$85,839,102 in benefits paid to or for participants and beneficiaries.
