Important Welfare Plan Information

May 2014

Dear Participant:

The Board of Trustees of the Chicago Laborersø Welfare Fund is pleased to announce some important changes to the health and welfare benefits provided by the Welfare Plan for active and retired participants. The changes explained in this Notice will be effective for eligible claims incurred on and after June 1, 2014.

- As we already announced, the Welfare Plan is eliminating the overall annual dollar limit on payment of eligible claims. Over the last few years, the overall annual dollar limit increased each year. It was \$2,000,000 for the 2013-2014 Plan Year. Effective for eligible claims incurred on and after June 1, 2014, the overall dollar limit will be eliminated altogether.
- The Welfare Plan is removing the eligibility exclusion for children age 19 or older who are eligible for other group health coverage through the childs employer or through the employer of the childs spouse, regardless of whether the child enrolls in such other coverage. The Welfare Plan will cover children through the end of the month in which they turn age 26, regardless of whether they are eligible for other group health coverage, effective for eligible claims incurred on and after June 1, 2014. If you would like to enroll a child who is now eligible as a result of this change, please call the Fund Office.
- ➤ We are proud to announce the creation of the Chicago Laborersø District Council Retiree Health and Welfare Fund. Effective June 1, 2014, we are launching a health and welfare plan to provide benefits just for our retirees. The new Retiree Plan will replace the current Chicago Laborersø Welfare Fundøs Retiree Plans (Basic, 1, 2, 3 and 4) even though the existing benefits will remain the same. The Chicago Laborersø Welfare Plan will remain in effect for active participants.
