## **SUMMARY ANNUAL REPORT**

# FOR HEALTH AND WELFARE DEPARTMENT OF THE CONSTRUCTION AND GENERAL LABORERS' DISTRICT COUNCIL OF CHICAGO

This is a summary of the annual report of the Health and Welfare Department of the Construction and General Laborersq District Council of Chicago, EIN 36-2151212, Plan No. 501, for period June 01, 2010 through May 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Health and Welfare Department of the Construction and General LaborersqDistrict Council of Chicago has committed itself to pay eligible claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with The Union Labor Life Insurance Company to pay life insurance, long-term disability and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2011 were \$82,405.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$152,786,992 as of May 31, 2011, compared to \$131,479,898 as of June 01, 2010. During the plan year the plan experienced an increase in its net assets of \$21,307,094. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$199,394,155, including employer contributions of \$167,063,819, employee contributions of \$7,586,890, realized gains of \$459,711 from the sale of assets, earnings from investments of \$20,802,341, and other income of \$3,481,394.

Plan expenses were \$178,087,061. These expenses included \$11,536,434 in administrative expenses, and \$166,550,627 in benefits paid to participants and beneficiaries.
