

**SUMMARY ANNUAL REPORT**  
**FOR HEALTH AND WELFARE DEPARTMENT OF THE CONSTRUCTION AND**  
**GENERAL LABORERS' DISTRICT COUNCIL OF CHICAGO AND VICINITY**

This is a summary of the annual report of the Health and Welfare Department of the Construction and General Laborers' District Council of Chicago and Vicinity, EIN 36-2151212, Plan No. 501, for period June 01, 2017 through May 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Health and Welfare Department of the Construction and General Laborers' District Council of Chicago and Vicinity has committed itself to pay eligible claims incurred under the terms of the plan.

**Insurance Information**

The plan has contracts with The Union Labor Life Insurance Company to pay life insurance, temporary disability and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2018 were \$94,675.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$293,494,622 as of May 31, 2018, compared to \$251,693,885 as of June 01, 2017. During the plan year the plan experienced an increase in its net assets of \$41,800,737. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$230,020,159, including employer contributions of \$208,766,566, employee contributions of \$1,304,652, realized losses of (\$989,765) from the sale of assets, earnings from investments of \$20,040,818, and other income of \$897,888.

Plan expenses were \$188,219,422. These expenses included \$9,024,048 in administrative expenses, and \$179,195,374 in benefits paid to participants and beneficiaries.

- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
