

SUMMARY ANNUAL REPORT FOR
CHICAGO & VICINITY LABORERS' DISTRICT COUNCIL
RETIREE HEALTH & WELFARE PLAN

This is a summary of the annual report for Chicago & Vicinity Laborers' District Council Retiree Health & Welfare Plan, EIN 46-5243652 Plan 501, for the year ended May 31, 2024. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$759,577,872 as of May 31, 2024, compared to \$655,644,317 as of June 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$103,933,555. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$211,950,190 including employer contributions of \$106,650,628, participant contributions of \$7,890,885, net investment gains of \$78,756,656 and other income of \$18,652,021.

Plan expenses were \$108,016,635. These expenses included \$6,927,154 in administrative expenses and \$101,089,481 in benefits paid to or for participants and beneficiaries.

transactions in excess of 5 percent of plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Paperwork Reduction Act Statement
